FILLIES AND MARES, THREE YEARS OLD AND UPWARD, WHICH WERE BRED IN ARKANSAS AND QUALIFY UNDER RULES GOVERNING SAME By subscription of \$300 each, which shall have been paid to A. T. B. H. A. on or before December 31, 2017. \$500 to enter and \$1,000 to start. \$100,000 Guaranteed (of which A. T. B. H. A. would furnished \$50,000) to be divided 60% to the Owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth with 2% being divided equally among all other finishers. Weight: 123 lbs. for 4-year-olds and up, 118 lbs. for 3-year-olds. Non-winners of \$25,000 in 2019 allowed 3 lbs.; \$20,000 in 2018 allowed 5 lbs.; \$15,000 in 2018 or 2019 allowed 8 lbs. Starters to be named through the entry box at time of closing. The Owner of the winner to receive a trophy. There is no split provision. If the number entering exceeds the starting gate capacity, the number to start will be determined under RULE 2258 of the Arkansas State Racing Commission's Rules of Racing, by the Stewards and by horses that have accumulated the highest earnings. No Owner can start more than one horse to the exclusion of a single entry. Supplementary nominations may be made by the closing time of entries at a fee of \$2,500.
