Supplementary nominations may be made by the closing time of entries at a fee of \$3,000 which qualifies to start with \$150,000 Guaranteed of which 60% to the Owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% to be divided equally between remaining starters. Weights: 122lbs. Non-winners of \$40,000 twice allowed 3 lbs.; \$40,000 once 5 lbs.; \$25,000 once 7 lbs. (Maiden and Claiming races not considered in allowances.) In Allowance Stakes starting preference will be given to horses that have accumulated the highest earnings. (See reverse side for additional starting limitation information).
